Amazon is able to attract talent due to their hyper-growth and innovative businesses, however, retaining talent has proven more challenging given its fast-charging, frugal, and aggressive culture.

Key Takeaways

- Amazon's entry into the market presents both a formidable competitive threat and a sizeable opportunity.
- There are several aspects of their culture and business model that make Amazon a force to be reckoned with:
 - Cult-like Leadership Principles and compressed business titles
 - Stock compensation structure that is back loaded to ensure employee retention
 - Diversified model with a variety of businesses that are aggressively outperforming and outgrowing their competitors across industries
- At the same time, it's challenging for Amazon to retain talent and there is a sense that there's a revolving door at the company.

The Potential to Transform the DMV from a Political to Tech Hub

Key Perspective

• If Amazon's headquarters were to be located in the region, the DMV has the potential to further solidify its status as a tech hub. There would be broad scale winners and losers in the local employment market should this happen.

Key Takeaway

- Similar to how Amazon and Microsoft impacted Seattle, the DMV could quickly evolve into a region that draws start-ups, tech companies, and other innovators and investors looking to capitalize on the anticipated growth.
- Amazon's HQ2 could cause severe "brain drain" in the region, attracting local tech talent and underutilized, highly-trained, government talent in particular.
